

### Parental Notification of Standardized Assessment

Pursuant to N.J.S.A. 18A:7C-6.6, beginning in the Fall of 2016 school districts must, by October 1 of each year, provide parents specific information on State assessments or commercially developed standardized assessments that may be administered to your child during the school year. It is very important to note that all students may not be administered all assessments. Additionally, the allotted time frames are approximate time frames and students may be permitted extra time or accommodations as outlined in an IEP or 504. Please do not hesitate to reach out to your child’s principal or counselor for additional details on accommodations and accessibility options.

### Notificación Parental sobre la Evaluación Estandarizada

Conforme con N.J.S.A. 18A: 7C-6.6, comenzando en el otoño de 2016, los distritos escolares deben, antes del 1 de octubre de cada año, proporcionar a los padres información específica sobre las evaluaciones estatales o evaluaciones estandarizadas desarrolladas comercialmente que pueden administrarse a su hijo durante el año escolar. Es muy importante tener en cuenta que a todos los estudiantes no se les pueden administrar todas las evaluaciones. Además, los plazos asignados son plazos aproximados y se les puede permitir a los estudiantes tiempo adicional o adaptaciones como se describe en un IEP o 504. No dude en comunicarse con el director o consejero de su hijo para obtener detalles adicionales sobre adaptaciones y opciones de accesibilidad.
