TO: The Honorable Members of the Board of Education

The next regularly scheduled meeting for the Board of Education will be held on Thursday, April 15, 2021 at 5:30PM in-person in the auditorium at the Perth Amboy High School Ioocated at 300 Eagle Avenue and via remote conference in order for the Board of Education to conduct its business. The meeting will be held in-person, and public comment will be held remotely through the use of electronic equipment and in-person.

Compliance is required with P.L. 1975, c. 231, with regard to the posting and publication of meeting notices, which was amended by (A3850/S2294) and approved by the Governor on March 20, 2020, permitting that during a period declared as a state of emergency, a public body shall be permitted to perform any of the following by means of communication or other electronic equipment: conduct a meeting and any public business to be conducted thereat, cause a meeting to be open to the public, vote, or receive public comment without being deemed to have violated the provision of P.L.1975, c.231 (C.10:4-6 et seq.) in performing such functions by means of communication or other electronic equipment.

Members of the public who wish to provide comment at this meeting may attend the meeting or do so through the remote conferencing system. The Conference Bridge phone number to dial into the meeting and the link to join via a computer or mobile device will be listed on the District's website on Monday, April 12, 2021. Members of the public will be able to join via conference or use this phone number to call into the board meeting.

Upon joining the meeting, members of the public will be muted to ensure that there is no disruption to the business being conducted by the Board of Education. Individuals will be welcomed to provide comment during the public portion of the meeting. Individuals will be invited to speak in the order the requests are received after using the raise hand feature.

Formal action will be taken. The Board reserves the right to retire into Closed Session, and to exclude the public from such portions of the meetings in accordance with the P.L. 1975, c.231, upon adoption of a conforming Board Resolution for Executive Session.
