- 1. Parents must report to the school Nurse if their child is COVID-19 positive upon determination immediately, and provide contact tracing information.
- 2. The school Nurse will notify the Principal and Nursing Supervisor Ms. Eva Kucaba.
- 3. Director of Personnel, Ms. Yolanda Gomez will be notified immediately.
- 4. The District will begin contact tracing in collaboration with the Health Department.
- 5. Parents of close contacts will be informed by the school Nurse that their child had contact with a person in the school who is confirmed to have COVID-19. To maintain confidentiality, the school Nurse **will not** provide the name of the student.
 - a. Parents of close contacts are also given guidelines for self-quarantine.
 - b. Close contact are those determined to be within 6 feet of an infected person for a cumulative total of 15 minutes or more over a 24-hour period starting from 2 days before illness onset (or, for asymptomatic patients, 2 days prior to test specimen collection) until the time the patient is isolated.

¿Qué está haciendo nuestro distrito para garantizar la seguridad de nuestros estudiantes durante esta pandemia?

PROTOCOLOS CUANDO UN ESTUDIANTE ES POSITIVO PARA COVID19:

- 1. Los padres deben informar a la enfermera de la escuela si su hijo es positivo de COVID-19 al momento de la determinación de inmediato, y proporcionar información de rastreo de contacto.
- La enfermera de la escuela notificará a la directora y supervisora de enfermería Sra. Eva Kucaba.
- 3. La Directora de Personal, Sra. Yolanda Gómez será notificada de inmediato.
- El Distrito comenzará a rastrear contactos en colaboración con el Departamento de Salud.
- 5. La enfermera de la escuela informará a los padres de los contactos cercanos que su hijo tuvo contacto con una persona en la escuela que se ha confirmado que tiene COVID-19. Para mantener la confidencialidad, la enfermera de la escuela no proporcionará el nombre del estudiante.

 Los padres de contactos cercanos también reciben pautas para la auto cuarente na.

b. Los contactos cercanos son aquellos que se determina que están a 6 pies de una persona infectada por un total acumulativo de 15 minutos o más durante un período de 24 horas a partir de 2 días antes del inicio de la enfermedad (o, para pacientes asintomáticos, 2 días antes de la recolección de la muestra de prueba) hasta el momento en que se aísla al paciente.

Si un estudiante es COVID-19 positivo

- Se informará a los padres sobre las pautas para el regreso del estudiante al aprendizaje en persona.
- Los estudiantes deben permanecer en casa durante 14 días.
- Debe proporcionar un resultado de prueba negativo antes de regresar.
- Dependiendo de la gravedad de los síntomas del estudiante, puede asistir a la escuela de forma remota.

Si un estudiante está en cuarentena debido a una exposición externa

- Los padres informarán a la enfermera de la escuela, la enfermera de la escuela discutirá las pautas para el regreso del estudiante al aprendizaje en persona.
- Los estudiantes deben permanecer en casa durante 14 días.
- Debe proporcionar un resultado de prueba negativo antes de regresar.
- Los estudiantes asistirán a la escuela de forma remota.

Si un estudiante está enfermo en el aula

- El maestro notificará a la enfermera de la escuela y enviará al estudiante para que sea evaluado.
- La enfermera de la escuela llevará a cabo una evaluación médica y determinará los próximos pasos en función de su experiencia médica.

WHAT CAN YOU AND YOUR FAMILY DO TO STAY SAFE DURING THIS PANDEMIC: OUÉ PUEDEN HACER USTED Y SU FAMILIA PARA MANTENERSE SEGUROS DURANTE ESTA PANDEMIA:

- Wash your hands for at least 20 seconds
- Stay at least 6 feet away from others
