- 8. Meeting open to the public for discussion of agenda items
 - <u>Public member #1</u> spoke about attendance policies 3212 and 4212 stating that staff are dedicated and those who come in a minute past their start time are marked late. If this happens four times they are docked ½ days pay. This is a harsh penalty and being a minute late doesn't interfere with instructional time. We ask that you please consider the harshness of the penalty.
 - <u>Public member #2</u> spoke about personnel item #4k on page 15. She is concerned about the start date for the new teacher as they are not following through with her child's IEP. She needs a teacher in there sooner than February. Will there be a certified special education substitute teacher in there until the new person starts or can that person start sooner? Also are all the certificates for the new teacher up to par?
 - <u>Public member #3</u> spoke about attendance policy 3212. Tonight this is on the agenda for the second reading. She was on the committee that discussed this policy and some of the revisions were not added or included in the new policy. The policy is harsh and lacks humanity. The penalty doesn't fit the infraction, please revisit the policy.
 - Public member #4 spoke able the attendance policy and asked that it be tabled because the
 consequences are extremely harsh. The fair labor standard act says you may dock and employee for
 lateness within reason. You can't dock for more than what they would have earned for the day. No one
 checks to see how late people stay after the contractual work day. We're willing to reconvene the
 committee to work collaboratively with Central Administration on this policy.
