She thanked the administration for providing the COVID protocols in the newsletter and asked if it's possible to arrange vaccinations for staff?

<u>Public Member #3</u> – Inquired if there is a tax increase contained in the preliminary budget. Asked why Amboy is constantly extending the superintendent's contract.

<u>Public Member #4</u> – Inquired what is happening with the Charles Street properties since they are an eyesore. Asked if the superintendent would rescind his request for a contract extension since his current contract has time left and the union contract is set to expire in July. If not, will the board consider holding.

<u>Public Member #5</u> – Spoke about K-5 age group not being a factor in virus spread. Schools are opening in other districts so if schools open on April 21st, what's the plan? We need better communication with the parents.

<u>Public Member #6</u> – Need better transparency regarding school re-opening and regarding board meetings. No info coming to parents or the community other than the letters in January and February.

Discussion ensued relative to the approval of the Superintendent's contract. Ms. Vazquez offered that the increase in the contract is \$50. The old contract was made up of base salary, merit pay, stipend for Doctoral Degree and a 2% raise. The new contract moves merit pay into the base salary, to eliminate merit pay. The community said that merit pay is not good and we listened. The superintendent will still have goals which he will be evaluated on. This contract was vetted by the County Superintendent and is comparable with similarly credentialed and experiences people in the same position. Some of our administrators waited to settle their contracts until the AFT contract was settled. The purpose of providing more time is because we believe in what he is doing. Our district is on the right path. The graduation rate has increased from the mid 50% to 80%. 50% of our graduates leave with the Seal of Biliteracy. DLS is moving to the 9th grade and our test scores have increased in all buildings.

Mr. Anderson stated that the most important item is for a student to possess a high quality education. Look at our scores for the SAT versus other schools. Reading and Writing scores are 301 of 308 and math is 282 out of 308. In a review of data from 2019, our high school score was 11, our middle schools were ranked 6 and 12 and our best elementary school was Wllentz, which was ranked 61%. The next best elementary school was 585 positions below Wilentz with the lowest being 910 positions below Wilentz. DLS is in the 80% percentile. The graph for the high school graduation rate is misleading as it should show growth has leveled off. Seal of Biliteracy is a good thing but all schools in Middlesex County have it. Distinguished Schools – anyone can get the recognition if you complete the paperwork. Lighthouse District – first you have to be a low performing school. I taught at Middlesex County College and most of our students would enroll in basic math because they didn't have sufficient background in that content area. 15 years ago, Mr. Gumbs got the high school project moving by working with Dr. Clausel and Mr. Rodecker, securing a site for the new high school. An international competition soon followed. If teachers sign a three-year contract and after the first year said they want a new contract, what would we say? My campaign promise was to provide the highest quality education for our students. The superintendent has yet to complete one full contract.

Dr. Brown thanked Mr. Anderson for the remembrance of Mr. Gumbs. We should not diminish the strides we've made. It matters who our quarterback is. Right now we have a superintendent who has made progress that we haven't had in years. It's not new about our students going to Middlesex County College but our students have made progress. We're doing the right thing for stability in our district. Where he has needed to provide accountability, he has.

Mr. Puccio stated that he has been on the board for 12 years and has worked for the city for 38 years. Some things are misleading. He was around when the high school was first started. However political interference squashed the initial project. The mayor interjected himself into the construction competition. We lost out because there was no plan in place when the Schools Construction Corporation went bankrupt. The worst thing you can do is to make this personal.

Mr. George offered that he has worked in the district longer than anyone. He taught at Middlesex County College and Rutgers. In three decades of superintendents, no one did anything to make our schools better. He's been on the board for three months and made his opinion based on what he's seen. We need someone who is a good quarterback.

Old Business

It was stated that we arrived to a conversation about what to do for the kids. We're trying to contribute for the betterment of the kids. We'll build a beautiful high school. Being a Lighthouse District is a big thing, we were recognized by our colleagues as an educator. We invite the AFT/leadership to work together. Just because the answer is no doesn't mean that we're not listening, it's because we're doing something different. There will be a board retreat next week and based upon those discussions, information will be sent out.
