15. I understand that the Board is relying on the truth of the statements I have made in this affidavit in admitting the student to the public schools and in incurring the cost and expense of the student's education. I further understand that:
- a. If any of the statement I have made are false, I may be subject to criminal prosecution for false swearing or for uttering a false writing under the New Jersey Code of Criminal Justice N.J.S.A. 2C:21-4a, 2C:28-2a. Both crimes are offenses of the fourth degree. A person who has been convicted of the fourth degree crime may be sentenced to a term of imprisonment no to exceed 18 months and to the payment of a fine not to exceed \$7,500.00. I also may be subject to prosecution for the disorderly persons offense of offering a false statement to a public office (N.J.S.A. 2C:21-3b), and a court may sentence me to a term of imprisonment not to exceed six months and payment of a fine not to exceed \$1,000. In any case, the court may require to make restitution to the Board to pay for the tuition of the student, as described below. \_\_\_\_\_ (Initial).
  - b. Any person who fraudulently allows a child of another person to use his residence and is not the primary financial supporter of that child and any person who fraudulently claims to have given up custody of his or her child to a person in another school district commits a disorderly persons offense under the Education Law. In the event that any of the statements that I have made is false and it is determined that the student is not eligible, I will be obligated to pay to the school district tuition for all days of illegal attendance. Tuition shall be based on actual costs per student, and shall include tuition for regular school year programs, summer school programs and enrichment programs. \_\_\_\_\_ (Initial)
