a. If any of the statement I have made are false, I may be subject to criminal prosecution for false swearing or for uttering a false writing under the New Jersey Code of Criminal Justice N.J.S.A. 2C:21-4a, 2C:28-2a. Both crimes are offenses of the fourth degree. A person who has been convicted of the fourth degree crime may be sentenced to a term of imprisonment no to exceed 18 months and to the payment of a fine not to exceed \$7,500.00. I also may be subject to prosecution for the disorderly persons offense of offering a false statement to a public office (N.J.S.A. 2C:21-3b), and a court may sentence me to a term of imprisonment not to exceed six months and payment of a fine not to exceed \$1,000. In any case, the court may require to make restitution to the Board to pay for the tuition of the student, as described below. \_\_\_\_\_ **(Initial)**.

b.
